- 第一條 國立臺灣大學工學院永續化學科技國際研究生博士學位學程(下稱本學程)為維護研究生之學位論文品質,依國立臺灣大學精進學位論文品質實施辦法第三條規定,訂定本準則。
- 第二條 本學程教師符合國立臺灣大學學則第六十九條規定者,得擔任論文指導 教授。

本學程教師擔任論文指導教授者,其指導研究生之新收人數,每學年至多 以八位為原則,指導研究生總人數至多以二十位為原則。

本學程教師就指導研究生人數如有超出前項規定之需求者,得於本學程 招生委員會審核同意後,由本學程招生委員會以借用名額之方式,向本學 程其他教師協調之。

第三條 本學程研究生之學位論文應與本學程專業領域相符,並經本學程學位考 試委員會審查確認。 本學程研究生之學位論文如有不符本學程專業領域爭議時,依國立臺灣

大學研究所博士暨碩士學位考試規則第十條第二項規定辦理。

第四條 本學程研究生之學位論文,應於定稿後,以排除引言、參考文獻、目錄及 附件之版本,由研究生自行或交由指導教授辦理學位論文原創性檢查作 業。

前項學位論文原創性檢查之比對相似度,應低於百分之二十五。

本學程研究生之學位論文原創性檢查比對相似度未符前項規定者,應提 出理由書,經論文指導教授確認並簽名。

- 第五條 本學程研究生應向本學程提交下列文件,始得辦理畢業離校手續:
 - 一、學術倫理暨原創性比對聲明書。
 - 二、學位論文原創性比對報告,如比對相似度未符前條第二項規定者,應 另檢附經論文指導教授簽名之理由書。
- 第六條 本準則經學程會議及院務會議通過後,自發布日施行,並報教務處備查。

NTU-SCST Thesis Quality and Management Standards 2023.12.19 Published in full

Article 1

The National Taiwan University College of Taiwan International Graduate Program of Sustainable Chemical Science and Technology (hereinafter referred to as "the Program") hereby establishes the following Thesis Quality and Management Standards (hereinafter referred to as "the Standards") to safeguard the quality of theses submitted by the Program's graduate students. The Standards are based on the provisions of Article 3 of the National Taiwan University Regulations for Improving the Quality of Theses.

Article 2

A faculty member of the Program who meets the requirements of Article 69 of the National Taiwan University Regulations may serve as a thesis advisor.

The number of new students that a faculty member of the Program may advise each academic year is limited to eight, and the total number of students that a faculty member may advise is limited to 20.

A faculty member of the Program who has a need to exceed the number of students permitted under the preceding paragraph may apply to the Program's Admissions Committee for approval. If the application is approved, the Admissions Committee may coordinate with other faculty members of the Program to borrow student slots.

Article 3

Thesis submitted by graduate students of the Program must be relevant to the Program's professional field and must be reviewed and confirmed by the Program's Thesis Examination Committee.

If a thesis submitted by a graduate student of the Program is deemed to be irrelevant to the Program's professional field, the matter shall be handled in accordance with the provisions of Article 10, Paragraph 2 of the National Taiwan University Regulations for Doctoral and Master's Degree Examinations.

Article 4

After the thesis is finalized, the graduate student or the thesis advisor may arrange for the thesis to be checked for originality. The originality check shall exclude the introduction, the reference list, the table of contents, and the appendices.

The similarity rate of the originality check for the thesis under the preceding paragraph shall be less than 25%.

If the similarity rate of the originality check for the thesis of a graduate student of the

Program is higher than the rate prescribed in the preceding paragraph, the student shall submit a letter of explanation that has been confirmed and signed by the thesis advisor.

Article 5

A graduate student of the Program must submit the following documents before the graduation and leave-of-school procedures can be completed:

- 1. A statement of academic ethics and originality check.
- 2. A report of the originality check for the thesis. If the similarity rate of the originality check is higher than the rate prescribed in the preceding article, the student must also submit a letter of explanation that has been signed by the thesis advisor.

Article 6

The Standards shall take effect on the date of their publication and shall be submitted to the Office of Academic Affairs at NTU for filing.
